The Quiet Time program is a practical, evidence-based approach to reduce stress and improve academic performance, student wellness and the school environment. It provides students with two 15-minute periods of Transcendental Meditation (TM) each day to help balance their lives and improve their readiness to learn. This school wide program complements existing educational strategies by improving the physiological underpinnings of learning and behavior. DLF funded programs include public and public charter schools in New York, Los Angeles, Chicago, San Francisco and Washington, D.C.

WOMEN'S HEALTH INITIATIVE: (Expenses \$ 274366 including grants of \$ 39617) (Revenue \$ 0)

The Women's Health Initiative had its fourth full year of operations and programming in FY16. The programs focus on women and girls who are survivors of domestic abuse and sexual violence offering Transcendental Meditation, an evidence-based, alternative therapy shown to heal and empower victims of abuse. Programs include the NYC Family Justice Center (an initiative of the Mayor's office to combat domestic violence and reduce barriers faced by victims of domestic abuse), St. Luke's Crime Victim Treatment Center (the largest hospital-based victim assistance program in New York), Girls Educational and Mentoring Services (GEMS), and the Women's Prison Association (WPA).
